Membership Affiliation

(b) has a material financial relationship with another Person that reasonably could be expected to interfere with the ability of either Person to meet their responsibilities of independent representation on the OIF Board of Directors or any OIF Committee; where "material financial relationship" includes, but is not limited to, the receipt of compensation for services as a consultant, and any joint venture or partnership arrangement with or stock ownership in, the Person in question.
